American democracy has seen two significant catalysts for restrictive election legislation in the past decade: The 2013 *Shelby* decision and the 2020 presidential election. Each sparked years of legislative action making it harder for eligible Americans to vote. Each tell the story of politicians and special interests doing whatever they can to limit democracy, avoid accountability, and maintain political power. Each will unfortunately influence and inspire restrictive election legislation for years to come.

Using historical data and our State Voting Rights Tracker, which tracks election legislation from 2021 to present, we found 25 laws restricting voter access or election administration were passed and enacted in preclearance states from 2011-2023, with 20 of those passed after the Shelby decision. (Like we experienced in recent years on abortion rights, in the run-up to the Shelby case, several states enacted laws in anticipation of Section 5 of the VRA being constrained, so those efforts are also captured in our analysis). An additional 19 laws with a mixed or unclear effect on voter access or election administration were passed in preclearance states from 2011-2023, with 17 passed post-Shelby. Restrictive and mixed/unclear laws that were approved by the Department of Justice or approved by a federal court from 2011 to 2013 pre-Shelby – while preclearance was still in effect – are not included in this analysis.

The most common types of restrictive elections laws we have seen since *Shelby* include photo ID, restrictions on mail and early voting, and voter list maintenance changes. Ultimately, many of the new restrictive voting laws we saw in the aftermath of the 2020 election, including in former preclearance states of Arizona, Georgia, Florida, and Texas, were able to take effect immediately because of the *Shelby* decision. This chart offers a summary of the types of legislation we saw in the run-up to and aftermath of the *Shelby* decision.
